- Music inside booth is okay, but sound level is subject to the discretion of SDA Event Staff (ES).
- Vendor may NOT sell beverages of any kind - Vendor may NOT sell food items that have not been pre-approved by SDA and/or not listed on this application.
- In order to receive refunded deposit, vendor must: adhere to the Dept. of Public Health Regulations, all fire code regulations (including on-site fire extinguisher) and a full clean up of the vendor site before vacating.
- Deposit refunds will be mailed to vendor within 10 business days of the completion of the event.
